| C | Negative Cross (Optional)       | 1 Minute (1 minute prep)   |
| D | Second Negative Constructive    | 2 Minutes (30 second prep) |
| B | Affirmative Cross (Optional)    | 1 Minute (1 minute prep)   |

## Round 3

## Closing Arguments

*Note: Each side has preparation time built in after each speech, which they may use at their discretion. Speech time not used may be transferred to prep time as necessary, but no additional time may be added to speeches. Penalty points will be assigned to teams that extend beyond allotted prep or speech time.*

- Indicates a handicap awarded in time for a given team because of the level of difficulty in this speech.
